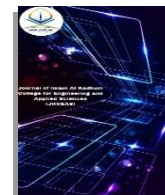

1. Introduction

2.1 Distance Learning

Distance learning can be explained in different ways but the most appropriate definition is that "it is an institution-based type of formal education where an environment is created that further facilitates the connection of a learning group to their respective correspondence which could be learners, instructors as well as an available resource through communication system" (Alao and Lawal, 2016).

This means that a student and a tutor located in different geographical locations can be connected by a single platform to teach and learn. The communication system most times is always interactive.

2.2 E-Learning

Electronic Learning (E-Learning) is a form of learning that involves learning through the use of digital devices for both teachings as well as learning. It is a two-way communication. As described by Moore et al (2010) "E-learning is the use of new multimedia technologies and the Internet to improve the quality of learning by facilitating access to resources and services, as well as remote exchange and collaboration".

E-learning is better explained, similar to distance learning but the difference is that E-learning requires multimedia technology and the internet while distance learning does not necessarily require that.

2.3 Online Learning

Online Learning is what is achieved from the implementation of E-Learning. SA (2015) described it by saying "Online Learning is eLearning with a mandatory involvement of a digital network which a learner needs to access at least part of the learning materials and services. Online learning refers to network-enabled teaching and learning that allows the learner to have increased interaction with content, teacher, and other learners".

This is also explained as a scenario where a student is engaged in online learning that involves interaction with a group as well as tutors assigned to a particular course. For this to take place, a network-enabled connection needs to be provided

2.4 Virtual College

A virtual College as described by SA (2015) "is higher education institution or network of higher education institutions responsible for design, development, and offer of courses and programs in a flexible and online environment". 2.5 Online Resource

Online resource as the name implies refers to resources that are found on the internet, which provides useful information for a study. Online resources can be in form of web pages or documents. 3. E-Learning main parts

3.1 Access Rights and Privileges

The access right and privileges described the amount of access each designated user has after logging into the system as an architecture. The student has limited access rights which may include registration, login, access to courses being offered, related study materials and resource, assessment and assignments, course progress, assessment scores, Online forum and discussion, and timetable. 3.2 E-Learning Resources

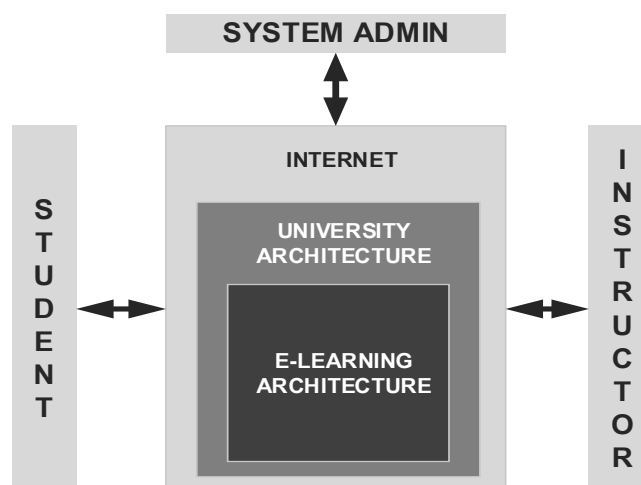


Fig.1. System Architecture [8]

System architecture can be described as in fig.1 Architecture [t sections [8]:

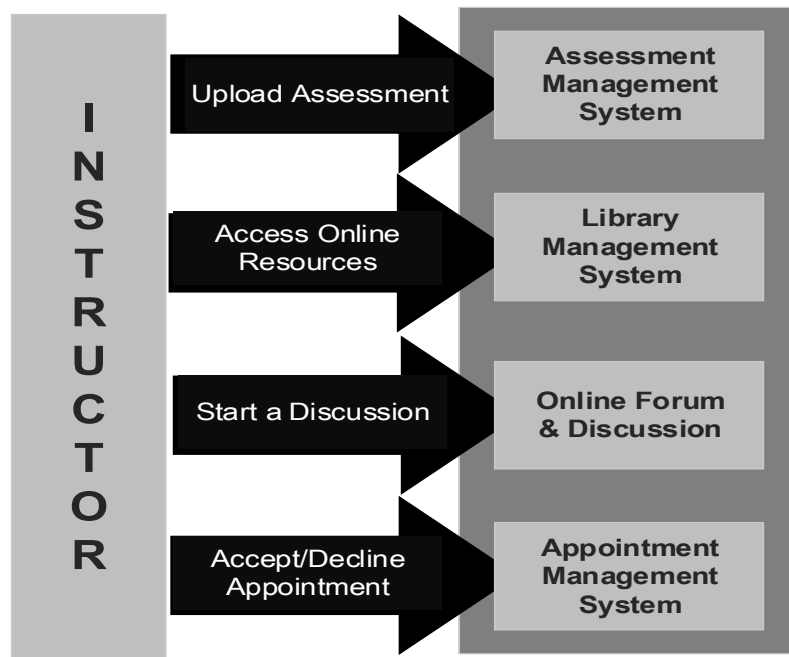


Fig. 2. E-Learning Architecture for Instructor [8]

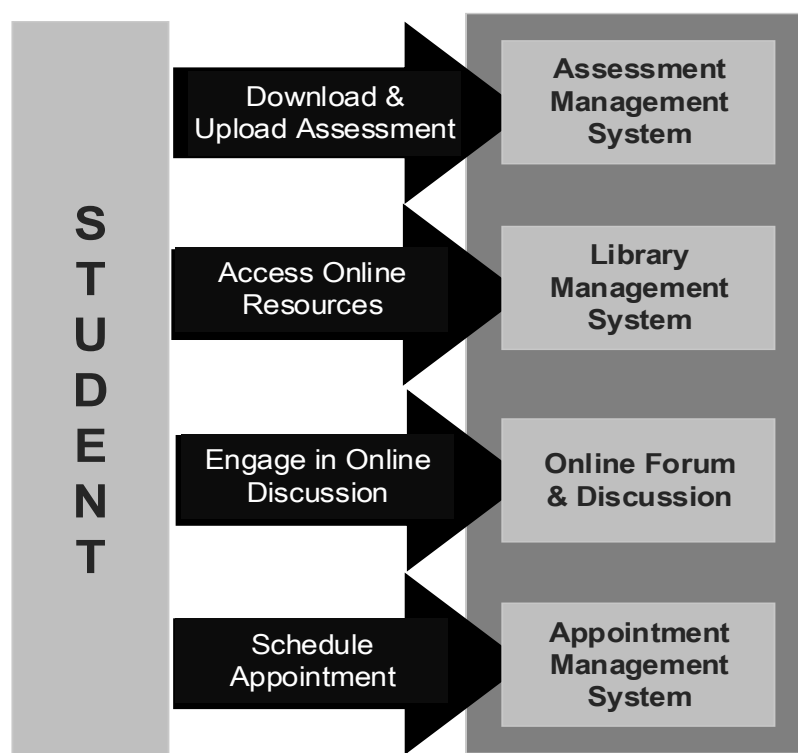


Fig 3. E-Learning Architecture for Student [8]

A typical example of this is MCSE offered by Microsoft.
- Third Category: This category of E-Learning system solution is designed as a general platform in which institutions from anywhere in the world can put up their online courses for students all over the world to enroll and take. Usually, this kind of setup comes as a part of the mainstream. A typical example of this is Edx.

Edx has been chosen to be a case study to understand the development, implementation, effect, and impact of E-Learning and Online solutions [12].

7. Edx as a Case Study

Edx is an E-Learning and Online Learning platform founded and developed by Harvard University and MIT. It offers high-quality education and courses from the best universities in the world. It has more than 90 global partners. Its mission is reflected in three phases: increase access to high-quality education for everyone and everywhere, enhance teaching and learning on campus and online, and advance teaching and learning through research [13].

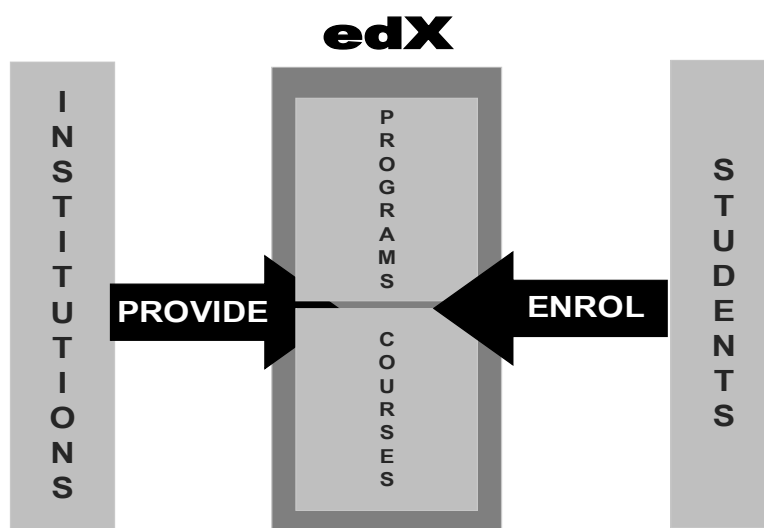


Fig.4. E-Learning Architecture for EdX [14]

Edx works in a very simple way: it connects prospective students to prospective colleges in two ways, see fig.4.

- A student can enroll in a course that is a part of a program and upon completion, the student will get a certificate. A typical example is a student enrolling for Web Design on Edx. Berkeley University of California provides the course. Upon completion, a certificate can be issued to the student [15].
- A student can enroll for a course that is a part of a program and upon completion, the student will have the option of getting a certificate for that particular course or using it as a prerequisite to enroll in other associated courses to complete a full program. A typical example is Essentials of Cybersecurity offered by the University of Washington. Essentials of Security is a 4-course program with entails 3 other more. Completing one will create a chance to complete the other three[16].

The Effects of Edx Architecture are:

- Career-focused

Most of the courses and programs come with career outcomes and most of the courses are validated by top companies. One important thing is that the course has job relevance and one can start immediately after the course is finished

- Pathway to Credits

This is more relevant, especially in MicroMasters Programs, a MicroMasters credential is comparable to one-quarter of one's semester's worth which forms about 25% of a regular master's degree. Finishing that would enable one to apply for the full degree and use credit from MicroMasters.

- Faster

Programs and courses take a shorter time, on average of about 4 to 12 weeks. This becomes very useful in master's as it allows one to accelerate the route to full degree completion

- Flexible

Learning is flexible as courses and programs are offered multiple times. This means a student has the privilege to take a course or program at his/her pace which makes it very flexible. This becomes very handy, especially for working professionals who combine work and study.

- Affordable

Most courses and degrees are very cheap compared to when the full degree is taken on campus. The cost of a traditional Master's program can be daunting, with an average of about \$8,000 to about \$20,000. Micro Masters cost about \$800 to \$1700. This gives an affordable approach to master's level education [13].

8. Integrating E-Learning Solution in Colleges (Imam Kadhum)

There is no doubt that the effect the E-Learning system solution has had on education cannot be overemphasized. It has succeeded in helping almost every category and age group to continue learning.

- Students looking at earning an international degree do not need to travel several miles before they earn a degree from their home.

- For working adults, it is made flexible so they can work and study at their own pace.

While the Effects on Integration E-Learning (Imam Kadhum) is :

- Because learning has become flexible, more courses can be offered to their students
- The physical barrier of having students from their locality will have been removed which means students from different states and countries within the Arab region can enroll in courses offered by the school through E-Learning System.

9. Methodology

The methodology gives a clear indication of how relevant data can be obtained as well as analyze it to further have an idea of what the implementation and integration of an E-Learning Platform might be for Imam Kadhum. Three different kinds of input are important in this case, which are:
